SPECIAL ENTERTAINMENT PERMIT

This is an application for a "Special Entertainment" permit, as that term is defined in Chapter 9 of the Cypress Municipal Code. This Special Entertainment Permit allows live entertainment to be conducted for five or fewer days per year subject to the provisions contained in Chapter 9 of the Cypress Municipal Code. By submitting this application, you are applying to be the permit holder, and thus one of the persons responsible for conducting Temporary Live Entertainment in the City of Cypress. Please completely fill out this application and note that incomplete applications will not be processed. If you require additional space to complete an answer, please feel free to note in the space provided that the answer is continued on an attached sheet of paper.

III. THE STATEMENTS BELOW REFLECT THE OPERATIONAL REQUIREMENTS FOR TEMPORARY LIVE ENTERTAINMENT IN THE CITY OF CYPRESS AS REFLECTED IN CHAPTER 9 OF THE CYPRESS MUNICIPAL CODE. BY INITIALING EACH STATEMENT IN THE BLANK SPACES PROVIDED, YOU ARE EVIDENCING YOUR INTENT TO COMPLY WITH THE APPLICABLE REQUIREMENTS.

_____ The proposed live entertainment shall not be held in any building, structure or other location within 300 feet of any approved residential property. For the purposes of establishing live entertainment businesses, all distances shall be measured in a straight line, without regard to intervening structures or objects, from the narrowest point of the building, structure or other location in which the live entertainment will be provided to the nearest property line of the residential property.

_____ The operation of the proposed live entertainment establishment will be carried on in a building, structure or location which meets and complies with all of the applicable federal, state, and city health, safety, zoning, building, and fire regulations and requirements.

_____ If the proposed live entertainment will be held within an approved structure, noise from the live entertainment shall not exceed the City's standards as contained in Section 13-68 of the Cypress Municipal Code as measured 50 from the structure.

_____ If the proposed live entertainment will be held in an approved open air location, the noise from the live entertainment shall not exceed the City's standards as contained in Section 13-68 of the Cypress Municipal Code.

_____ At least one security guard shall be on duty outside the premises, patrolling the grounds and parking lot at all times that live entertainment is offered. The security guard(s) shall be charged with preventing violations of law and enforcing the provisions of this Chapter. All security guards shall be uniformed so as to be readily identifiable as a security guard by the public. No person acting as a security guard shall act as a doorman, ticket taker or seller, or similar functionary while acting as a security guard.

_____ The entire exterior grounds, including new parking lots, shall be lighted to 3-foot candles, minimally maintained and evenly distributed, as measured at ground level to permit the security personnel to observe activity on the ground and within automobiles.

- _____ No exterior door or window of the premises shall be propped or kept open at any time while the business is providing live entertainment.
- _____ There shall be no drinking of alcoholic beverages on any exterior portion of the premises, including, but not limited to the parking lot of the establishment.
- _____ There has not been created an excessive need for police services attributable to the establishment. For the purposes of this section, the phrase “excessive need for police services” shall mean that the establishment providing live entertainment has generated a need for police services greater than a similar establishment which does not provide live entertainment, as measured by the number of police responses to the property; or that the police services are in response to activity involving the brandishing or use of a firearm, knife, or other deadly weapon at the establishment, or activity involving any crime chargeable as a felony which has resulted in bodily injury.
- _____ The live entertainment event shall comply with all requirements of the Cypress Municipal Code.
- _____ The applicant and property owner of the facility where the live entertainment will be held has read Chapter 9 of the Cypress Municipal Code and is familiar with and understands its contents.
- _____ The City may suspend or revoke a live entertainment establishment permit issued pursuant to Chapter 9 of the Cypress Municipal Code for any violation of any of the above requirement or any other requirement of Chapter 9.

I DECLARE UNDER PENALTY OF PERJURY THAT I HAVE READ AND UNDERSTAND THE ABOVE REQUIREMENTS, AND THAT I WILL COMPLY WITH ALL OF THE ABOVE REQUIREMENTS AND I UNDERSTAND THAT MY PERMIT MAY BE SUSPENDED OR REVOKED FOR ANY VIOLATION OF ANY OF THE ABOVE REQUIREMENTS OPPOSITE WHICH I HAVE PLACED MY INITIALS.
