

## CITY OF CYPRESS RECREATION AND COMMUNITY SERVICES MEN'S and CO-ED SLOW PITCH SOFTBALL LEAGUES - ROSTER AND HOLD HARMLESS AGREEMENT

In exchange for participating in this activity, I hereby agree on behalf of myself and my spouse, parents, children, family, employees, agents, heirs, estate, executors, representatives, administrators, insurers, successors and assigns, distributees, guardians and/or other legal representatives (collectively the "Released Parties") to fully release and to not make any claim against, file a lawsuit against, attach the property of, or prosecute the City of Cypress (the "City") and/or the Cypress Recreation and Park District (the "District") and/or either of their employees, officers, elected and appointed officials, volunteers, boards, departments, agents, contractors and/or anyone else acting on its/their behalf for any and all claims, causes of action, including, but not limited to, emotional distress, bodily injury, death, or property damage arising out of any actions by any City or District employees, officers, elected and appointed officials, volunteers, boards, departments, agents, contractors and/or anyone else acting on the City's and/or the District's behalf in connection with my participation in this activity. I UNDERSTAND THIS RELEASE SHALL BE EFFECTIVE EVEN IF THE LOSS, DAMAGE OR INJURY WAS NOT FORESEEABLE OR RESULTS, IN WHOLE OR IN PART, FROM THE NEGLIGENCE OF THE CITY, DISTRICT AND/OR ANY OF THE ABOVE PERSONS. I understand that this activity involves the risk of serious injury and even death, and I agree to assume any and all risk of serious injury or death in participating in the activity.

In case of accident or other emergency, personnel of the City or District and/or their agents, are hereby authorized to secure medical care deemed necessary by them, as a result of that accident or injury, for me at my cost and expense. I further agree to indemnify and defend the City and/or the District and/or both of their employees, officers, elected and appointed officials, volunteers, boards, departments, agents, contractors and/or anyone else acting on its/their behalf and to pay for any and all costs incurred (including, but not limited to, medical treatment, pain and suffering, emotional distress, any settlement paid or judgment, legal costs and/or attorneys' fees) as a result of any injury that I cause to another participant. I further consent to the use of activity/event photography and/or video taping of me and the display of those pictures of me for promotional use, including on the City's Internet site. By signing below, I acknowledge and represent that **I HAVE READ THIS AGREEMENT CAREFULLY, I FULLY UNDERSTAND ITS CONTENTS AND I VOLUNTARILY AGREE TO ITS TERMS.** No oral representations, statements or inducements, apart from this written agreement, have been made. If any portion of this agreement is declared invalid by a court, the remainder shall continue in full force and effect. I declare under the penalty of perjury under the laws of the State of California that I am eighteen (18) years of age or older and am fully competent to sign this agreement. **CODE OF CONDUCT:** ANY INFRACTION OF THE FOLLOWING RULES OF CONDUCT WILL RESULT IN THE IMMEDIATE DISQUALIFICATION OF THE PLAYERS, PLAY OR TEAM INVOLVED. NO PLAYER SHALL appear on the field of play, or in gym, at any time in an intoxicated condition. PENALTY: suspension for season and if violation occurs again, suspension from all league play in Cypress Recreation and Park District. NO PLAYER SHALL at any time lay a hand upon, push, shove, strike, or threaten to strike an official. NO PLAYER SHALL use profane, obscene or vulgar language in any manner at any time. NO PLAYER SHALL refuse to abide by an official's decision. NO PLAYER SHALL be guilty of objectionable demonstration of dissent at official's decision by throwing gloves, bats, balls, or other forceful action. NO PLAYER SHALL be guilty of using unnecessarily rough tactics in the playing of the game against the body or person of an opposing player or of any other type of unsportsmanlike conduct. NO PLAYER SHALL be guilty of personal abusive verbal attack on any player, official, or spectator. NO PLAYER SHALL be guilty of physical attack as an aggressor upon any player, officials, or spectators. NO PLAYER SHALL smoke while going on or coming off the field of play or while on the field of play, or in gym area. NO PLAYER OR FANS SHALL bring alcoholic beverages to the field or gym. NO METAL CLEATS SHALL be permitted on the field. IF MANAGER OR ACTING MANAGER IS EJECTED FROM THE GAME FOR ANY OF THE ABOVE, THE GAME SHALL BE DECLARED AN AUTOMATIC FORFEIT.
